Highlights Report

1. 2024/25 levy and Budget Consultation

The Management Agency undertook consultation with beekeepers on a proposal for the American Foulbrood Beekeeper Levy for 2024/25 levy to remain the same at \$40 per beekeeper, with an increase of 25 cents from \$1.70 per colony to \$1.95 per colony.

The consultation was run from the 06 October 2023 and consultation closed on 20 October 2023. (https://afb.org.nz/levy-consultation/).

A total of 74 submissions were received: 70 of these were completed on SurveyMonkey, either online or by post. 30 submitters were in favour of the proposed levy rates and 30 were against. Two emails and two written submissions were also received.

All submissions have been analysed and considered by the Management Agency Board, who have decided to progress with the proposed levy rates.

The Management Agency will notify the 2024/25 rate of levy in December 2023 on the website and through emails.

2. Annual report 2022/23

3. Certificates of Inspection (COI)

A total of 4,301 non-DECA holders were informed of the requirement to complete a Certificate of Inspection on 9 August 2023. As of 31 October 2023, 570 Certificates of Inspection had been completed, up from the 470 COIs completed in the same period the year before.

COI reminders (email, SMS) were sent on 4 September, 5 October, and 19 October. Weekly email reminders will continue to be sent out during November.

- The number of colonies on registered apiaries decreased from 718, 587 to 587,208.
