Highlights Report

1. Decline in colony numbers and downstream effects

With a 10% decrease in hive numbers within the past calendar year, there will be implications for pollination services and potentially production volumes for horticultural producers in spring. The final colony numbers will be available in early June at the end of the ADR period.

2. AFB PMP review

The Management Agency met the new Minister of Biosecurity in late February. The Minister informed the Management Agency that MPI is assessing the AFB PMP recommendations submitted in March 2023. MPI have advised that the Minister has requested the scope be extended to include governance of the Management Agency. The Management Agency has requested a copy of the Terms of Reference for this element of the PMP assessment from MPI, but this has yet to be received.

3. Certificates of Inspection

2,148 beekeepers owning 20,371 colonies on 3,899 apiaries completed a COI prior to 15 December 2022, slightly down from the previous year (2,639). A further 276 beekeepers have completed a late COI up until 05 April 2024. As of 5 April 2024, 699 registered beekeepers are still in default of their 2023 COI obligations. Together, they own 5,397 registered colonies on 1,339 apiaries. Eight beekeepers own more than 100 colonies.

In late February 2024, 92 beekeepers were scheduled for COI default inspections based on the criteria of >10 colonies or > 5 apiaries. These 92 beekeepers own 2,617 colonies on 408 apiaries. COI default inspections commenced from 1 March with inspections already completed for 45 COI defaulters who own 381 colonies on 129 apiaries. Ten cases of AFB have been found so far during these inspections.

4. New AFB heat map

The Management Agency has a new AFB heat map, which replaces the former static heat map. This new map displays AFB cases on pre-set zoom levels that has been locked to prevent breach of privacy. It also shows the approximate locations of current AP2s and the operational/regional split between the two

Operations Managers. The map will be updated each year on 31 May and 1 March, with old data removed.

5. New Apiary Coordinator

On 6 March 2024, the Management Agency confirmed the appointment of Paula Rich as the new fulltime Apiary Coordinator, replacing Leonie Elliott-Mason. Paula is based in Rolleston and will be starting on 15 April, to allow for a period of training and handover from Leonie. Leonie will move to a part-time role with the Management Agency for the month of May, to assist with the peak ADR period.

6. Honey Surveillance

The Management Agency will be taking a pause from conducting honey surveillance this year, due to the following reasons:

- a. Overall costs of \$49,000 (AP2, collection of honey samples, testing) for running this surveillance would get invoiced in the 2024/25 budget. With a \$220,000 loss in revenue forecasted for next year, the Management Agency is taking a precautionary approach and re-prioritising this budget to AP2 inspections for investigating AFB hot-spots or for HiveHub functionalities for acquiring lab test results instead.
- b. A pause would appear to incentivise those beekeepers who have consistently kept up with their elimination efforts over the past three years.

Targeted honey surveillance will continue for those beekeepers where there is cause for concern on hidden AFB risks. This approach was endorsed by the Board on 15 March 2024. The Management Agency will be updating beekeepers about this change.

5. ADR and 2024/25 levy

The ADR period is now active. As of 05 April 2024, 106 beekeepers have filed their ADRs, 125 have submitted colony return, and 207 have paid their levies.
